Membership fee

The finances of VLGST are to be secured through membership and entry fees.

The entry fee amounts to **CHF 5.000,00** and must be paid once.
Upon request it can be split up throughout three years.

To support the concerns of VLGST and its membership and to secure the financial stability of the association, a non-binding recommendation is given by the board in order to assist with the determination of the membership fee:

The foundation board determines the yearly membership fee on CHF _____.
The amount can be adjusted any time. The minimum amount is **CHF 1.000,00**.

Additionally required documents

To prove the statutory requirements for the membership the following documents (copies) are attached to the application.:

- Statutes of the foundation
- Extract from the Liechtenstein Commercial Register (not older than 3 months)
- Confirmation by the auditing body that the foundation is exclusively and irrevocably non-profit
- Confirmation that the foundation is subject to the Liechtenstein Foundation Supervisory Authority (STIFA)

By signing this application for membership, the applicant confirms that the foundation has its own assets, uses these assets for non-profit purposes and is generally not dependent on donations or collections for its activities.

The applicant has taken note of the articles of VLGST and accepts them as binding upon admission.
